1. **RELEASE AND WAIVER:** The Participant (and the Guardian) and the Participant’s heirs, executors, administrators, assigns and anyone else who may make a claim for or on behalf of the Participant (the “Releasers”) release, waive, discharge and covenant not to sue or commence any action against The Edge Taekwon-Do Academy, its employees, officers, directors, contractors, agents, volunteers, sponsors, event organizers and any other person or organization assisting or involved in the Activities (the “Releasees”) from or for all liability, and waive against the Releasees all claims, demands, damages, actions, causes of action or any recourse whatsoever arising out of or in respect of any loss, personal injury or damage to property incurred from or arising out of or connected with the Participant’s participation in or attendance at the Activities, including travelling to and from such Activities or resulting from any decision of any Releasees, notwithstanding any such loss, personal injury or damage to property that may have arisen by reason of the negligence of any Releasees.
  
2. **INDEMNITY:** The Participant (and the Guardian) and the Releasers agree to indemnify and hold harmless the Releasees from and against any liability, loss, damages, expenses, costs, claims, demands, actions or causes of action arising out of or in consequence of the Participant’s participation in or attendance at the Activities, including travelling to and from such Activities or resulting from any decision of any Releasees.
  
3. **ASSUMPTION OF RISK:** The Participant is in proper physical condition to participate in the Activities. The Participant (and the Guardian) understands that the practice of Taekwon-do and the Activities are by their nature risky and hazardous, and accepts and assumes personal responsibility for those risks and hazards notwithstanding that any personal injury or loss of property which the Participant may incur may be due to the negligence of any of the Releasees.
  
4. **POLICIES AND SAFETY EQUIPMENT:** The Participant will observe strictly the policies, terms, conditions, rules and regulations of The Edge Taekwon-Do Academy and other instruction as communicated by its instructors, and will wear proper safety equipment, as determined by the instructors. The Participant’s failure to wear proper safety equipment or comply with the policies, terms, conditions, rules or regulations and other instruction as communicated by the instructors can result in temporary or permanent expulsion from the training or competition area, the Activities and/or The Edge Taekwon-Do Academy altogether. Any student neglectfully or willfully damaging the property of The Edge Taekwon-Do Academy shall be (or guardian in the case of a minor) responsible for cost of replacement or repair.
  
5. **COMMUNICATION:** The Participant (and the Guardian) consents and conveys to The Edge Taekwon-Do Academy the right to communicate with the Participant (and the Guardian) via email.
